

GO TRAVEL PASS

Terms and Conditions

Register and Purchase of Go Travel Pass.

1. Any individual 12 years old and above may register in the Go Travel Pass program at Flair Airlines website flyflair.com. Go Travel Pass is available for purchase on a limited online offer only.
2. The purchasing individual must provide valid personal information as required from time to time in order purchase the Travel Pass.
3. Select your preferred travel pass type and complete the registration.
Go Travel Pass - \$499
Go Travel Pass – Unlimited \$699
Price are subject to applicable tax.
4. Upon successful purchase, an email confirmation with your login and Go Travel Pass Number will be sent to your designated email address.
5. The Travel Pass is for individual consumers only. Travel agencies, wholesalers, consolidators, and other persons or entities engaged in the selling or distribution of air transportation or packages comprising air transportation are not eligible for the purchase of the Travel Pass.
6. Flair Airlines reserves the right at any time to determine and re-examine the purchase eligibility, as well as the right to modify or otherwise amend the eligibility requirements.
7. Flair Airlines reserves the right, at any time, to verify the status of the purchaser, including the verification of information provided by the purchase and making a request for additional information to ensure that the purchaser meets the Travel Pass purchase terms and conditions.
8. The Travel Pass can only be used by the Travel Pass owner. Pass members must promptly notify Flair Airlines upon becoming aware of any unauthorized use of Go Travel Pass.
9. Travel Passes are non-refundable.
10. Flair Airlines reserves the right, at any time, to verify the status of the purchasing individual, including requiring additional information that does not meet the Go Travel Pass' terms and conditions. Flair also reserves the right to cancel the Go Travel Pass should it determine that the eligibility criteria have not been met or are no longer valid.
11. Go Travel Pass member will have access to a dedicated portal by using their login credentials provided in the email confirmation. The Go Travel Pass is not available and will not apply to bookings created outside the dedicated portal.

Booking of Flights for Go Travel Pass.

1. Go Travel Pass members must login <https://gotravel.flyflair.com/> to book flights and will require member login ID.
2. Flight bookings must be made at least 2 days in advance of travel.
3. Passenger Name and date of birth must exactly match to the registered Go Travel Pass member.
4. Your Go Travel Pass Account Number will be applied as "payment" towards the base fare of Flair flights only. Member must pay for the taxes, applicable fees and additional services being purchased together with the booked flight (during or after the original booking).
5. Only one Go Travel Pass member maybe booked at a time (except for infants under 2years old).If traveling with a child or other paying companion, please contact our Call Center.
6. Flight bookings for GO TRAVEL PASS members are NOT PERMITTED on Fridays and Sundays and on Feb14-17 and Apr 10-13, 2020. While, GO TRAVEL PASS - UNLIMITED are permitted on any days of the week including holidays.
7. Flight bookings for all Go Travel Pass members are subject to availability. Space may be limited for bookings made close to the departure date and during peak travel periods. For this reason it is recommended that you book and confirm flights as far in advance of travel as possible.
8. Travel must be booked and completed within the validity period. No extensions permitted.
9. Flights and routes may be seasonal and are subject to change without notice at any time; flights and routes might also operate on a limited frequency.
10. The booking and travel are subject to all applicable Flair Airlines rules, policies, terms and conditions of carriage and tariffs. For special services (e.g. unaccompanied minors, customers with special needs, travelling with an infant / child, travelling with a pet) is subject to conditions and restrictions; click [here](#) for more information.
11. Flair Airlines reserves the right at anytime on its own discretion cancel the Go Travel Pass membership and all related flight bookings if it should determine that the purchase of the Travel Pass does not meet the program Terms and Conditions, including abuse of privileges, or misrepresentation of any information provided to Flair Airlines).

Changes and Cancellations.

1. Go Travel Passes are non-refundable, notwithstanding Pass holder's cancellation allowance of 24hours from the time of purchase. Request for cancellation, please contact Flair Airlines.
2. Date changes on flight bookings are allowed at least 48 hours prior to travel, free of charge. Changes made at less than 48 hours to the original scheduled travel, a Change Fee will apply at \$125 per direction.

3. Changes must be completed in the self-serve "Go Travel Pass" online portal. Any request for change done at the Call Center or at our Airport Counters are subject to applicable Service Fee.

4. No refund, in whole or in part, will be issued for any Go Travel Pass bookings or credited to future travel.
